New business:

Motion by Tina Huppert, second by Ruth Esanbock, to give President Larry Johnson \$75 for gas reimbursement for picking up ATV signs.

President Larry Johnson received a letter from Brad Lawrence, Corporation Counsel, and will have to go to the Highway Traffic Safety Commission before the Highway Committee in the future to request new ATV/UTV routes. The Highway Traffic Safety Commission meets quarterly, so route requests will have to meet these deadlines. Ruth Esanbock asked if person taking care of ATV crossings could come out and view Hwy. 29 and 72 again.

Doug Walker from the St. Croix Club and Don Fuller want to set up an ATV ride in the Birchwood Area. Can camp at Featherstone Campground and ride would begin at Ed's Pit Stop.

Members were encouraged to ride their ATV's to club meetings. Meetings are scheduled as follows:

Virgil Weberg asked about route in Stockholm and Pepin County is working on this route.

Sheldon Huppert asked about ATV/UTV map on website and it will be updated.
