Sheldon Huppert reported the banner is made for the fair booth and maps are being updated, enlarged and laminated. Thank you to Sheldon Huppert! Darren Place and Sheldon Huppert will set-up the Fair Booth on Wednesday night. Volunteers were recruited to work the fair booth shifts and an email will be sent out to recruit more volunteers.

New Business:

Reminder that the WATVA NW Regional Meeting is August 17th, 2019 at 8:30 a.m. at the Barron County playground east of Almena, WI on the trail.

Jeremy had a call from the Union Town Chairman regarding the dust from the condensed traffic into Plum City mainly from Pepin County and asked who enforces speed limits. Several citations have been given out. Elmwood is looking into opening more routes under Act 87 on roads under 35 mph and no signing is required.

Vice-President Place will check into a fundraiser for the ATV/UTV Association advertised at Broz.

A meeting will be held at the Nauti Hawg next year since the schedule for 2019 has already been set.

The next meeting will be held at Sneakers in Spring Valley on Monday, August 19th at 6:00 p.m. Motion by Everett Muhlhausen and seconded by Darren Place to adjourn the meeting at 7:07 p.m. Motion passed.
