Matt Feuerhelm asked why we paid out money in taxes this year. The association never had many funds previously so now we applied for non-profit so will not have to pay taxes in the future.

Joanne Gulbranson asked the number of members in the Pierce County ATV/UTV Association; it is now 210.

Question was asked how to drive into Prescott but there is no access at this time. Everett Muhlhausen told members they need to contact their County Board Supervisors and request to open all county roads for ATV/UTV travel. Members should also contact the City of Prescott and members in Clifton need to contact the Town Board to request routes.
